MISSIONS AND EVANGELISM: WEST AFRICA - "A Church Changes an Entire Village" Global Servants establishes, builds, and develops churches in 5 countries in West Africa - Ghana, Burkina Faso, Togo, Benin and Cote d'Ivoire. Our Bible School trains pastors for these new churches to spread the love of Christ and reach hundreds of new converts each year. They also build clinics, provide medical care and dig wells that supply clean, fresh water to entire villages. Currently, there are over 40 congregations usually in small, remote villages, which have 1 pastor and average 100-150 people on a Sunday. In 2012, Global Servants opened House of Grace - Ghana - a safe haven for young girls at risk of being sold into child slavery. The home houses ten young girls (the government limit per facility) and a second home is in the planning stage. Through the home, the little girls are provided with food, clothing, housing, education and medical care. THAILAND - "Saving Little Girls for Big Destinies" Global Servants founded the House of Grace in 1988, located in Northern Thailand, as a home for tribal girls at risk of being sold into sexual slavery. House of Grace has rescued hundreds of girls, before the horror of child prostitution became a reality. House of Grace, with over 100 girls in residence, raises and educates the girls in a loving Christian atmosphere.

CHRISTIAN TRAINING EVENTS: NATIONAL INSTITUTE OF CHRISTIAN LEADERSHIP - Designed for Christian leaders who desire a transformational change in their life and ministry, the National Institute of Christian Leadership, led by Dr. Mark Rutland, is a year-long program to take their ministry to the next level. COUPLES CONFERENCES - This unique conference, presented by Dr. Rutland and his wife Alison, combines fun and laughter with practical solutions to common problems that all couples face. Through this conference, couples are better equipped to celebrate the richness of their marriage covenant. OTHER EVENTS - Dr. Rutland is a dynamic preacher and teacher helping the believer to walk in the deep places with God. His schedule offers several opportunities annually for teaching/preaching throughout the nation and the world. Mark Rutland also leads a tour of the Holy Land every year.
